

Facts about fluoride

What is fluoride?

Fluoride is nature's cavity fighter and occurs naturally in varying amounts in water sources such as rivers, lakes and even the oceans. Fluoride is naturally present to some extent in certain foods and beverages, but the levels vary widely. To help protect teeth from cavities, fluoride is also added to some dental products such as toothpaste, mouthwash and fluoride varnish.

What is fluoride varnish?

Fluoride varnish is a dental treatment that can help prevent, slow or stop tooth decay from getting worse. Fluoride varnish is made with fluoride, a mineral that can strengthen tooth enamel (the outer coating on teeth).

Keep in mind that fluoride varnish treatments cannot completely prevent cavities. Fluoride varnish treatments can best help prevent decay when also using the right amount of toothpaste with fluoride when brushing, flossing regularly, getting regular dental care and eating a healthy diet.

How is fluoride varnish put on the teeth?

Fluoride varnish is painted on the top and sides of each tooth with a small brush. It is sticky, but hardens once it comes in contact with saliva. When used on children, the child may feel the hardened varnish with their tongue but will not be able to lick it off. The application of the varnish does not hurt, however, young children may still cry before or during the procedure. Fortunately, brushing on the varnish takes only a few minutes.

Fluoride varnish codes (Medicaid-eligible)

D1206 and 99188 will be reimbursed at the same rate. Each can be billed two times per year, equaling four fluoride varnish treatments per year.

D1206	<ul style="list-style-type: none"> • Topical application of fluoride varnish by a dental provider • Patient must be under 21 years of age • Limit 2 applications per year per patient • Code can only be billed once within a 6-month period • Service provided at a dental visit • D1206 <u>cannot</u> be billed in conjunction with D1208
D1208	<ul style="list-style-type: none"> • Topical application of fluoride – excluding fluoride varnish • Same description applies as D1206
